- 1. To Constitute the District Admission Monitoring Committee (DAMC).
- 2. To see that, all the Un-aided Private Management Schools shall register in the Portal as per the Schedule, without any deviation.
- 3. To issue written instructions to all the Deputy Educational Officers, Mandal Educational Officers, to monitor Registration of all the schools (Following IB/ICSE/CBSE/State Syllabus running Class I )concerned from 19.04.2025.
- 4. To give publicity on the process of admissions in all the Means of publications i.e, Pamphlets, Banners at all Schools, offices of DEOs, APCs, DyEOs and MEOs and all District/Mandal Officers, through print media and electronic media, in Social Media ie, Facebook, Instagram, Twitter (X), Whatsapp, You Tube etc.
- 5. Arranging public meetings for awareness in the public on the Act and the process of registrations with schedule.
- 6. To issue of Instruction to the Education Assistant in Grama and Ward Secretaries to coordinate with the Parents and Public while they register their children for admissions in Private Schools.

In this regard, all the Regional Joint Director of School Education, District Educational Officers & Ex-Officio Project Coordinators, Additional Project Coordinators, Samagra Shiksha in the State are directed to follow the above instructions strictly without any deviations. Any deviation will lead to initiation of disciplinary action against the defaulters, as the issue is under the observation of the Hon'ble High Court.
