### **ORDER:**

In the G.O. 1<sup>st</sup> read above, Government has issued guidelines for implementation of "THALLIKI VANDANAM" scheme, a key initiative, designed to empower mothers/guardians across the State, by extending financial assistance of Rs.15,000/- per annum per child to every eligible mother/guardian, regardless of the number of children for sending their children to Schools from Classes I to XII (including Intermediate Education) in all recognized Government, Private Aided and Private Unaided schools/ Jr. Colleges including Residential Schools / Junior Colleges in the State from the Academic year 2025-26.

2. This scheme focuses on making school education more accessible and inclusive, with a commitment to provide equal opportunities and improve learning outcomes. The Scheme empowers the mothers to actively involve in their children's schooling from Class I through Class XII (including Intermediate), while recognising their pivotal role in shaping educational progress. By fostering this engagement, the scheme aims to boost student enrolment and lay the groundwork for long-term social and economic advancement across the State.

3. Accordingly, based on the verificataion of the beneficiaries by the GSWS Department, the Director of School Education, in the reference 2<sup>nd</sup> read above, has furnished the list of eligible beneficiaries and requested the Government, to accord permission to him to launch the "THALLIKI VANDANAM" Scheme for the Academic Year 2025-26.

4. Government after careful examination of the matter, has decided to launch "THALLIKI VANDANAM" Scheme for the Academic Year 2025-26 and accordingly hereby accord administrative sanction for an amount of Rs. 10,090.74 Crores covering 67,27,164 number of students and 42,69,459 mothers @ Rs.15,000/- per annum per child to every eligible mother/guardian and permit the Director of School Education, to launch the Scheme for the Academic Year 2025-26.

5. An amount of Rs.2,000/- per each student shall be deducted at source from the beneficiary and utilized for the overall development of Educational Ecosystem in the State. The said deducted amount of Rs.2,000/- will be credited to the relevant account under the control of the District Collector. The utilization of the said fund shall be towards schools/Jr.College maintenance, hygiene/sanitation and such other items as per the SOP to be worked out by the School Education Department.

6. In accordance with the above, Government hereby further orders that implementation of the "THALLIKI VANDANAM" Scheme for the Academic Year 2025-26 shall be carried out as per the following instructions: -

a) The list of eligible students after taking into consideration the probable admissions into 1<sup>st</sup> class/Jr. Inter, invalid records etc. would be as follows:

**b)** The Welfare Corporations under Welfare Departments shall implement the scheme in respect of the beneficiaries belonging to their respective departments and shall accordingly issue sanction proceedings as per the following list of beneficiaries. ## Details of eligible beneficiaries (Excluding 1<sup>st</sup> Class and Junior Inter admissions):

**c)** The following points should be observed while disbursing financial assistance:

## (i) Students admitted under 12(1)(C) of RTE Act, 2009:

In respect of the 74,887 students admitted in Private Management Schools under 12(1)(C) of RTE Act, 2009, the fees

prescribed by the Government should be deducted from the financial assistance under THALLIKI VANDANAM Scheme and the balance amount only should be credited to the beneficiaries.

# (ii) Students receiving Pre-matric & Post-matric Scholarships:

In case of the SC, ST, BC, Minority etc students who come under the purview of the Pre-matric and Post-matric Scholarships under the existing Centrally Sponsored Schemes (CSS), the eligible amount payable to those beneficiaries under those CSS Schemes shall be met from the budget of concerned departments through their respective SNA accounts and the balance amount payable to those beneficiaries under "THALLIKI VANDANAM" scheme shall be paid. All the welfare departments shall also follow the guidelines prescribed for such disbursement from SNA accounts.

## (iii) Admissions into 1<sup>st</sup> Class & Junior Intermediate:

The expected eligible enrollments in Class-I and Jr. Intermediate will be considered for financial assistance after completion of enrollment process for the A.Y 2025-26.

# (iv) Invalid & No Household data (1,12,711 students):

The disbursement of the amount to such beneficiaries would be released only after verification and rectification as per rules.

- **d)** The Finance Department shall issue necessary BROs to the Welfare Departments for the implementation of "THALLIKI VANDANAM" scheme through their respective Corporations. The Welfare Departments shall issue necessary administrative sanction orders as per the BROs issued by the Finance Department.
- e) The GSWS Department shall establish a robust online grievance redressal mechanism with dashboards to ensure that all
